	who, at the date of his death, was aged 24 years old. The inquest was

4	CIDCUMET ANCEC OF THE DEATHY
<b>T</b>	CIRCUMSTANCES OF THE DEATH
	On 16/12/15 at approximately 7.15am, Lee James Nauman left for work
	from his home address on his Yamaha 125 motorcycle. He drove along
	Lee Lane, a single carriageway two-way road with no markings dividing
	the opposing the lanes. It is accessed from the B6146 Cottingley Moor
	Road and eventually leads to M & M Yorkshire Stone at Bank Top. He
	travelled towards Bank Top until he reached Moor View Crescent, which
	forms a 90-degreeT-junction to the left before a short row of houses
	associated with Moor View Drive. It was as he travelled along Lee Lane
	in the direction of Cottingley Moor Drive that he lost control of his
	motorcycle and slid diagonally across the road directly into the path of an
	oncoming vehicle, causing him to sustain fatal head injuries. The court
	heard evidence to suggest that he may have been speeding up to the
	collision, notwithstanding the poor road and weather conditions.
	Although there was some evidence to suggest that he may have taken
	cannabis the previous evening, it was thought not to be conclusive.

## **CORONER'S CONCERNS** During the course of the inquest I heard evidence from (Collision Investigator), who conducted an examination of the road surface approximately 32.4 metres to the Cottingley side of the collision scene and found that the extreme nearside edge of the road surface was broken and crumbling away, leaving a pothole approximately 4 metres long and 5ccm deep encroaching onto the road surface approximately 0.6 metres from the extreme nearside edge. He also found an area of leaf and soil debris upon the road surface 14 metres in length across the whole width of the road encompassing the pothole. Although there was no evidence to suggest that this caused or contributed to the loss of control of the motorcycle, was unable to discount the possibility that it may have had a contributory effect. The MATTER OF CONCERN is as follows. = To review the road conditions at the location and to consider the appropriateness of remedial action. **ACTION SHOULD BE TAKEN** In my opinion action should be taken to prevent future deaths and I believe that Bradford MDC has the power to take such action. YOUR RESPONSE You are under a duty to respond to this report within 56 days of its date; I may extend that period on request. Your response must contain details of action taken or proposed to be taken, setting out the timetable for such action.
