1	<p><b>CORONER</b></p> <p>I am David Urpeth, assistant coroner, for the coroner area of South Yorkshire West</p>
2	<p><b>CORONER'S LEGAL POWERS</b></p> <p>I make this report under paragraph 7, Schedule 5, of the Coroners and Justice Act 2009 and regulations 28 and 29 of the Coroners (Investigations) Regulations 2013.</p>
3	<p><b>INVESTIGATION and INQUEST</b></p> <p>On 29.4.16, I commenced an investigation into the death of Carol Leesley. The investigation concluded at the end of the inquest on 9.12.16. The conclusion of the inquest was Natural Causes.</p>
4	<p><b>CIRCUMSTANCES OF THE DEATH</b></p> <p>Mrs Leesley died in Northern General hospital on 25.4.16. She died of 1(a) Septicaemia 1(b) Urinary Tract infection.</p>
5	<p><b><u>CORONER'S CONCERNS</u></b></p> <p>During the course of the inquest the evidence revealed matters giving rise to concern. In my opinion there is a risk that future deaths will occur unless action is taken. In the circumstances it is my statutory duty to report to you.</p> <p>The <b>MATTERS OF CONCERN</b> are as follows. –</p> <p>During the inquest, evidence showed the GP made a safeguarding report on 4.3.16, but for reasons unknown, despite there being an automated acknowledgment, the referral was not acted upon.</p> <p>It was unclear whether this was a case of unanimous error or IT error.</p>
6	<p><b>ACTION SHOULD BE TAKEN</b></p> <p>In my opinion action should be taken to prevent future deaths and I believe you [AND/OR your organisation] have the power to take such action.</p>
7	<p><b>YOUR RESPONSE</b></p> <p>You are under a duty to respond to this report within 56 days of the date of this report, namely by 6<sup>th</sup> March 2017. I, the coroner, may extend the period.</p> <p>Your response must contain details of action taken or proposed to be taken, setting out the timetable for action. Otherwise you must explain why no action is proposed.</p>
