| 2 | CORONER'S LEGAL POWERS |
| | I make this report under paragraph 7, Schedule 5, of the Coroners and Justice Act 2009 and regulations 28 and 29 of the Coroners (Investigations) Regulations 2013. |
| 3 | INVESTIGATION and INQUEST |
| | On 3 January 2020 HM Assistant Coroner Mr Guy Davies commenced an investigation into the death of Caitlin Ann SWAN. The investigation concluded at the end of the inquest before me on the 17 February 2021. |
| | The conclusion of the inquest was Road Traffic Collision. |
| 4 | CIRCUMSTANCES OF THE DEATH |
| | On 28 December 2019 sometime after 1300 Caitlin was descending Tubbon Hill between Stithians and the junction with the A393 to Ponsanooth on her road bicycle. A vehicle travelling in front of her down the hill was obliged to slow down to walking pace to negotiate an acute turn into Trebost Lane off to the left. Caitlin lost control of her bicycle as she attempted to slow down behind the vehicle, collided with the rear of the vehicle and fell into the path of an oncoming vehicle sustaining catastrophic head and neck injuries. |
| 5 | CORONER'S CONCERNS |
| | During the course of the inquest the evidence revealed matters giving rise to concern. In my opinion there is a risk that future deaths will occur unless action is taken. In the circumstances it is my statutory duty to report to you. |
| | The MATTERS OF CONCERN are as follows. – |
| | There are no signs on Tubbon Hill to warn road users of the junction with Trebost Lane, notwithstanding that the junction is only visible between 75 and 50 metres away for a road user descending the hill and that any vehicles negotiating the acute left turn into Trebost Lane are likely to be almost stationary in the road at some point. |
| 6 | ACTION SHOULD BE TAKEN |
| | In my opinion action should be taken to prevent future deaths and I believe you have the power to take such action. |
| | In my opinion action should be taken to prevent future deaths and I believe you have the power to take such action which may include a review of road signage. |
