UPON the Claimant's application for the hearing to be conducted in private

AND UPON hearing counsel for the Claimant on notice to the Respondent, but without notice to the Defendants

AND UPON the Court being satisfied pursuant to CPR 39.2(3) that it is necessary to sit in private because it is necessary to secure the proper administration of justice and publicity would defeat the object of the hearing

AND UPON the Court granting a disclosure order against the Respondent

AND UPON the Court making an order preventing the Respondent from revealing the terms of that disclosure order

AND UPON the Court being satisfied that non-disclosure of the full terms of the disclosure order is necessary to secure the proper administration of justice
