- iii) Wear any article of clothing with an attached hood (whether detachable or not) in a public place or a place to which the public have access unless in inclement weather i.e raining.**
- iv) Own, use or have with him any mobile telephone or telephone SIM card the phone number and IMEI number for which has not been disclosed to the Chief Constable of Essex Police or appropriate Police Force for the area in which he resides**

4. the court found that he had disobeyed/breached that order by

- 1 In respect of count 3 on 16th December 2019 he was in possession of a mobile phone not having informed the police of the number, which he admitted
- 2 In respect of count 8 on 19th December 2019 he was in possession of drug paraphernalia namely deal bags
- 3. In respect of count 9 on 19th December 2019 he wore a hooded garment in public when the weather was not inclement
- 4. In respect of count 10 on 19th December 2019 he wore a hooded garment in public when the weather was not inclement
- 5. In respect of count 11 on 19th December 2019 he had more than £100 in cash in his possession

without good reason and/or proof where it came from
6 In respect of count 12 on 1st April 2020 he was in possession of a mobile phone not having informed the police of the number, which he admitted

5. and imposed the following sentence(s) for those breach(es)
