1. An application having been made by⁽¹⁾ Mira Shah for committal of⁽²⁾ Murali Krishna-Murty to prison for disobeying the order dated 20 July 2018. The court on 24th February 2020 made an order sentencing Murali Krishna-Murty to a term of imprisonment of 2 months suspended on terms of compliance with the order of 20th July 2018.

An application having been made for the suspended sentence to be activated as Murali Krishna-Murty had not complied with the terms of the order of 24 February 2020.

The relevant terms of the orders and the allegations made by the applicant are recited on the attached notices to show good reason!

IMMEDIATE CUSTODIAL ORDER

2. It is ordered that Murali Krishna-Murty be committed for contempt to Her Majesty's Prison at Wormwood Scrubs for a total period of 2 months or until lawfully discharged if sooner and that a warrant of committal be issued forthwith.
3. And the contemnor Murali Krishna-Murty can apply to the Family Court at Uxbridge, District Judge Ahmed to purge his contempt and ask for release.

PROVISION FOR COSTS

4. And it is ordered that Murali Krishna-Murty do pay the costs of and occasioned by the application to commit and of each hearing arising from the application on the indemnity basis.

5. At the hearing

(1) MIRA SHAH was represented by counsel – Richard Carron

(2) MURALI KRISHNA-MURTY appeared in person on 26th May 2021

The court read the affidavits of Bendika Johal (affidavit) of 29th May 2019 and 30th April 2020 Date affidavit(s) sworn

The court heard no oral evidence. Mr. Krishna-Murty made submissions throughout the hearing.

In the course of his submissions he accepted that he had been served on 26 March 2020.

The court offered Mr Krishna-Murty the opportunity to seek to adjourn for legal advice and representation. He did not make such an application.

6. And the court is satisfied having considered the facts disclosed by the evidence that Murali Krishna-Murty has been guilty of contempt of court by disobeying the order dated 20th July 2018 and that he had proper notice of the terms of the order of 24th February 2020 and that he wilfully and deliberately failed to comply with the terms under which the sentence of imprisonment was suspended, the sentence of imprisonment is activated in full
