I. The appeal be allowed on grounds I, 2, 3, 4(b) and 5.

- 2. Paragraphs I and 3 of the Order of Mr Justice Fraser dated 30 July 2020 pursuant to which the Respondent was granted judicial review on Grounds I and 2(g) and the Appellant's decision of 18 July 2019 was quashed and the Order of Mr Justice Fraser dated 24 September 2020 made at the consequential matters hearing pursuant to which the Appellant was ordered to pay the Respondent's costs be set aside.
- 3. The Respondent shall pay the Appellant's costs of and occasioned by the Respondent's claim for judicial review (including the Appellant's costs of this appeal), to be assessed on the standard basis if not agreed.
- 4. Paragraph 3 of this Order shall not be enforced save following and in accordance with a determination by a Costs Judge of the amount which it is reasonable for the Respondent to pay in accordance with section 26(1) of the Legal Aid, Sentencing and Punishment of Offenders Act 2012 and regulations 15 and 16 of the Civil Legal Aid (Costs) Regulations 2013.
- 5. The Respondent's costs of the claim (including the Respondent's costs of this appeal) shall be the subject of a detailed assessment in accordance with the Civil Legal Aid (Costs) Regulations 2013.
