- 4. Nothing in paragraphs 1 to 3 above shall prohibit the Defendant or its insurers from disclosing the Claimants' names, address or any other information tending to identify them to their reinsurers, their legal and professional advisers or to HM Revenue & Customs or any other person required by law.
- 5. There shall be permission to apply in respect of this order.
