 28 days' imprisonment, to run concurrently;
- (iv) On 19 July 2020 the defendant allowed Chad Day to enter and remain at the Property, in breach of paragraph 1 of the Order –
 28 days' imprisonment, to run concurrently;
- (v) On 23 July 2020 the defendant played or allowed loud music to emanate from the Property, in breach of paragraph 2 of the Order –
