1. Introduction

PK indicated that he was aware of a pending case which had been identified which would be suitable, if possible, to be heard in a Newcastle courtroom (where the parties were located). MF indicated that he was aware of another case (<u>Porky Pint</u> [2022] EWHC 1705 (Admin)) where the Venue Determination indicated that steps would be taken with a view to it being heard in a Teesside courtroom if possible. Any such cases would continue to be managed from the Leeds Administrative Court Office.

MF also mentioned the prospect of a Divisional Court sitting at ACL. PB noted that this has occurred in the past.
